Vendor waives any claim against The Crazy Merchant, Inc., the hosted venue. The Vendor assumes all liability for loss or damage to Vendor's property entrusted to the premises.

Vendor shall hold The Crazy Merchant, Inc., the hosted venue, harmless and shall indemnify The Crazy Merchant, Inc., the hosted venue against all liability or expense arising out of any claim or injury or damage to any person or property together with all costs in connection with defense thereto, including attorney's fees. The Crazy Merchant, Inc., The Crazy Market mentioned parties will not be held responsible if show is cancelled for any reason.

Vendors are not permitted to resell items purchased from other vendors at the same show or sell any merchandise that is not handmade goods unless permission is granted prior to market. The Crazy Merchant, Inc. reserves the right to demand removal by Vendor of any item which may not be in keeping with the show's image. The Crazy Merchant, Inc. reserves the right to make rules and regulations and any interpretation as is set forth by The Crazy Merchant, Inc. and may be updated at any time.

Cancellation

SPACE RENTAL FEES WILL NOT BE RETURNED IF VENDOR CANCELS. Any Vendor who fails to show up for any show for which he/she has contracted will forfeit space rental fee. Any Vendor cancellations within 2 weeks of the show will not be credited towards the next market as there is not enough time to find replacements for your space. Should any show be cancelled by The Crazy Merchant, Inc. for any reason, this contract is null and void, and Vendor waives any and all claims, except

for space rental fee return. No REFUND is given if a show is cancelled for WEATHER or ACT of God related conditions. The fee will be carried over to the next available show.

Vendor Responsibilities

Vendors are responsible for providing all equipment INCLUDING tent (canopy with sides), tables, chairs, etc. All tents (no matter what size) must be secured with weights (concrete weights, water barrels, sandbags, etc.).

Vendors are responsible for set-up, operation, maintenance, and tear down of their booth area. Set-up begins at 9:30am, your booth must be set up and ready to vend by 10:50am. Tear down may commence at end of market at 5pm, not before. If you arrive later than 10:15am your space may be filled by another vendor to fill market, and we will put you at a different location where space is available. If you are not set up by 10:50am or leave before 5pm you will not be able to participate in future events as a vendor. Vendors are responsible for cleaning area after use. You must remove trash. Bring a broom if necessary, to clean your area during and/or after market.

Vendors are expected to comply with all federal, state and local laws, rules and regulations, and shall have all appropriate licenses, permits and other required documentation. You must have a City of Littleton sales tax license if you are selling goods. You must handle your own taxes including sales taxes, insurance and health permits (if applicable). The Crazy Merchant, Inc. will not be held liable for Vendors' actions. The Crazy Merchant, Inc. will not be responsible for accidents or lost articles. Liability insurance is the responsibility of each Vendor.

Vendors must comply with all State and Local Health regulations.
No smoking in booths by Vendors. This is a Health Department Rule.
No pets allowed.

Any disruptive behavior by booth operator and/ or their employees will not be tolerated. You will be asked to leave and not be able to sell until permission is granted by Market Manager to return. Rules, if violated, will result in being asked to leave and not invited back for another event. All Rules and Regulations violations are the sole discretion of the Market Manager.
